Subba Reddy Institute of Technology, Opp. Dupadu Railway Station NH-44, Lakshampurama (Post), Kurnool-518218, Andhra Pradesh** should submit fresh online application through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.
